- 7. Complex/Building/Structure Type: <u>This building was used historically as the Sexton's House at Valley Brook Cemetery.</u>
- 8. Architectural Style: **Other Style** (Wood Frame Front Gabled Building).
- 9. Building Support System: Wood timbers resting on grade serve as the building's foundation.
- 10. Dimensions: L <u>20' 5" N-S</u> x W <u>14' 5" E-W</u> = Square Feet <u>297.25</u>
- 11. Number of Stories: One.
- 12. Building Plan (footprint, shape): **Rectangular Plan**.
- 13. Landscaping or Special Setting Features: The Valley Brook Cemetery is located at the northwest edge of Breckenridge at approximately 9500' elevation. The cemetery features well-laid-out gravel roads, and cemetery lots often marked by wrought iron fences and native stones. The site's vegetation includes native Ponderosa and Lodgepole pines, along with scattered groves of Aspen trees, as well as native shrubs, grasses, and wildflowers. The cemetery is in a gently sloping valley, with an east-facing slope rising gradually above the cemetery to the west. The Sexton's House is located on the north side of Columbine Street, near the cemetery's entrance.
- 14. Associated Buildings, Features, or Objects Describe material and function (map number / name):

 Other features at the cemetery include: the entry gate, located at the cemetery's entrance from

 Airport Road; a wrought iron fence, paralleling Airport Road and forming the cemetery's east
 boundary; a paupers' burial area; roadways within the cemetery; grave markers and

monuments; wrought iron fences and gates enclosing several cemetery lots; native stones, outlining several cemetery lots or individual graves; and benches.

- 15. Roof: <u>Steeply-pitched front gabled roof, with rolled green asphalt roofing material over 1x</u> wood decking; boxed eaves.
- 16. Walls: Painted pale green vertical wood plank exterior walls, over wood frame construction.
- 17. Foundation/Basement: **Wood timbers on grade foundation; no basement.**
- 18. Chimney(s): There is no chimney, however, a metal stovepipe protrudes through the roof, near the north end of the west facing roof slope.
- 19. Windows: Single window openings are located on the building's east, north, and west elevations, all with painted dark olive green wood frames. The windows on the east and west elevations are covered with heavy wood shutters, side hinged with metal strap hinges. The window on the north (rear) elevation is covered with vertical wood planks.
- 20. Doors: <u>Paired, painted dark olive green, solid wood doors are centered on the building's south</u> elevation (facade).
- 21. Porches: The doors on the south elevation open onto a non-historic wood ramp and stoop.
- 22. General Architectural Description: The Sexton's House is located within Valley Brook Cemetery, on the north side of Columbine Street, not far from the cemetery's entrance at Airport Road. The modest building measures 20' 5" north-south by 14' 5" east-west, and is oriented to the south.

 Supported by a wood timbers on grade foundation, the Sexton's House features painted pale green vertical wood plank exterior walls, over wood frame construction. The roof is a steeply-pitched front gable, with rolled green asphalt roofing material, over 1x wood decking. The roof eaves are boxed.

 There are no chimneys, although, a metal stovepipe protrudes through the roof near the north end of the west facing roof slope. Single window openings are located on the building's east, north, and

west elevations, all with painted dark olive green wood frames. The windows on the east and west elevations are covered with heavy wood shutters, side hinged with metal strap hinges. The window on the north (rear) elevation is covered with vertical wood planks. Paired, painted dark olive green, solid wood doors open onto a non-historic wood ramp and stoop, centered on the building's south elevation. The Sexton's House is in good condition, and displays a high degree of historical integrity.
